

STARSHIP SYDNEY AS SEEN ON MARRIED AT FIRST SIGHT – ISLAND GETAWAY GIVEAWAY

PROMOTIONAL TERMS AND CONDITIONS

These Terms and Conditions constitute the guidelines for participating in Starship Sydney's 'Married at First Sight Island Getaway Giveaway' promotion ("Promotion"). By entering this Promotion, participants accept and agree to abide by these Terms and Conditions.

The Promotion is organized by SeaLink Marine and Tourism Pty Ltd (ABN [17 008 272 302](#)) ("Promoter").

Eligibility

The Promotion is open to any new wedding bookings onboard Starship Sydney from 29 January 2024 till 29 March 2024. Wedding Day must be hosted onboard Starship Sydney on or before 30 June 2025. Wedding events must meet minimum spend guidelines; events are non-commissionable. This promotion is open to all who meet the above criteria in accordance with these Terms and Conditions.

Employees of the Promoter, its related entities, affiliates, subsidiaries, agencies, and suppliers, along with their immediate family members or individuals residing in the same household, are ineligible to participate. If Wedding event is not hosted onboard Starship Sydney due to unforeseen circumstances, the prize will be forfeited and retained by SeaLink Marine and Tourism to redraw.

Determining and Notifying the Winner(s)
